



AGREEMENT BETWEEN FUTURE ELECTRONICS, INC.
AND KENT G. ANDERSON

This Agreement ("Agreement") is made and entered into as of the last date of execution by the parties, between FUTURE ELECTRONICS, INC. ("Future Electronics") and KENT G. ANDERSON ("Anderson").

WHEREAS, a dispute has arisen between Future Electronics and Anderson regarding his use and registration of the FUTURE-formative marks; and

WHEREAS, the parties desire to settle this dispute without litigation;

Now, therefore, in consideration of the mutual covenants and obligations set forth in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Representations and Undertakings of Kent G. Anderson. Anderson represents and warrants the following:

- a. that he has not used or registered, nor will he ever seek to use or register, the FUTURE-formative marks in connection with order fulfillment services or electronics, including, but not limited to, retail services featuring electronics; distribution services featuring electronics; inventory replenishment services in the field of electronics; testing, calibrating and programming electronic components for others; and, product design and testing services in the field of electronic components, tools, and test equipment;
- b. that he shall file with the USPTO enclosures A-F to this agreement, which seek amendments to trademark applications, Serial number 76/155,262; 76/247,198; 76/212,083; 76/235,435; 76/312,587; and 76/299,227.

2. Representations and Undertaking of Future Electronics. Future Electronics represents and warrants the following:

- a. that it shall move to suspend the consolidated opposition proceedings once Anderson files with the USPTO the trademark application amendments found at enclosure A-F to this agreement, and will move to dismiss the consolidated opposition once the USPTO amends the applications accordingly.

3. Entire Agreement. This Agreement constitutes the entire agreement between Future Electronics and Anderson with respect to the subject matter hereof, and there are no agreements between Future Electronics and Anderson with respect hereto except as expressly set forth herein.

4 Modification. This Agreement shall be effective as of the Effective Date and shall continue to be effective unless modified by written agreement between the parties.



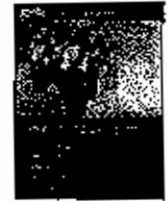
